

Director's Report on Developmental Progress Assessment

Overview

Aslan visited our center for a developmental progress assessment. The evaluation indicated information processing delays and developmental delays leading to acquired features of autism. At this stage, Aslan does not fully meet the diagnostic criteria for autism; however, the presence of risk features requires structured intervention and ongoing monitoring. Additional analyses are necessary to understand underlying biological or developmental contributors.

Recommended Plan

1. Development Protocol for Information Processing

1. Begin and maintain a structured developmental protocol addressing information processing.
2. Duration: 4 months, followed by reevaluation (preferably in person).
3. Reestablish baseline progress at the next evaluation.
4. Continue current interventions while adapting as necessary.

2. Main Recommended Analyses (Through Neurazon, Canada)

The recommended tests are external and performed through Neurazon (Canada). These are not conducted directly in our centers. Results will be analyzed and discussed with the guardian once available. Please refer to their report and assessment.

3. Therapy

- **Speech Therapy (ST):** 2 sessions per week.
- **Occupational Therapy (OT):** 1–2 sessions per week.
- **Mitotherapy (Light-Based Therapy):** 1–2 sessions per week, supportive to speech and occupational therapy.

Conclusion

This assessment highlights information processing and developmental delays with acquired autism features. Although Aslan does not currently qualify as a case of autism, these findings stress the importance of immediate structured intervention and deeper biological analyses. With consistent therapies and timely reassessment, the child remains open to significant improvement.

The recommended tests are external and performed through Neurazon (Canada). These are not conducted directly in our centers. Results will be analyzed and discussed with the guardian once available.


