### Director's Report on Developmental Progress Assessment

#### Overview

Jad Qadoura attended a developmental assessment at our center. The assessment indicates information processing delays and global developmental delays, which are currently contributing to acquired features of autism. Further analysis is recommended to better understand the underlying contributing factors and to guide a more targeted intervention plan.

#### Recommended Plan

##### 1) Development Protocol

- Proceed with a structured development protocol targeting information processing for **4 months**, then **reevaluate**, preferably **in person**.
- During reevaluation, we will **reassess the plan and establish a clear baseline** to measure progress and set appropriate next-stage goals.
- **Continue the current intervention plan** during this period, with consistent attendance and home follow-through as advised.

##### 2) Therapy

After determining the key contributing factors, the following therapy is recommended:

- **Plasticity rehabilitation therapy/ OT, intensive**
  - Planned as **intensive rehabilitation therapy in 4 months**, aligned with the reevaluation timeline and findings.

The recommended tests are conducted through **Neurazon (Canada)**, a bioinformatics company partnered with certified laboratories worldwide.
