Director's Report on Developmental Progress Assessment

Overview:

Hamad was assessed at our center on 10-09-2025. The evaluation indicated information processing delays and regressive developmental delays associated with brain atrophy and brain abnormalities as shown in previous analyses. The child also presents with abnormal epileptic activity, for which he is currently under medication to reduce seizure intensity and occurrence. Despite these challenges, Hamad demonstrates potential for improvement with structured protocols and intensive therapeutic support. Continued monitoring and analyses are essential to guide his developmental pathway.

Recommended Plan:

1) Development Protocol for the Information Processing

- Continue with the structured development protocol for 4 months.
- Reevaluate the child after 4 months, preferably in person.
- Reassess progress and establish a new baseline.
- Continue to align therapy with his neurological and developmental needs.

2) Main Recommended Analyses:

The recommended analyses are provided through Neurazon (Canada). These are external, optional tests intended to support a deeper understanding of Hamad's developmental profile. They are not conducted directly at our center. Please refer to their report and assessment.

3) Recommended Therapy:

- **Neuroplasticity rehabilitation therapy (intensive, to start as soon as possible).**
This approach will support brain plasticity, cognitive development, and adaptive functioning alongside his medical care for seizure management.

Hamad presents with regressive developmental delays influenced by neurological abnormalities and epileptic activity. Intensive therapy combined with continued medical management and specialized analyses is essential for his progress. He remains open to improvement, and consistent monitoring will help guide the next steps in his individualized plan.


