
Director's Report on Developmental Progress Assessment

Overview

Christian visited our center for a developmental progress assessment. During the evaluation, Christian showed **information processing delays** and **developmental delays**, which are currently leading to **acquired features of hyperlexia**, closer to *Hyperlexia Type 2*. These features fall under the category of **acquired high-functioning autism traits**, driven primarily by delays in processing and developmental pathways rather than classical autism.

At this stage, the child **does not score as a confirmed case of autism**, but the pattern indicates a risk of further progression if not addressed through early intervention. Continued monitoring and targeted intervention are strongly recommended. The child requires **further analyses** for a clearer understanding of underlying biological components influencing development.

Recommended Plan

1) Development Protocol for Information Processing

- Implement the developmental (non-medicinal) protocol for **4 months**.
 - Reevaluate Christian after 4 months, **preferably in person**.
 - Reestablish baseline levels of information processing and developmental performance.
 - Continue adapting the intervention plan based on progress.

2) Recommended Tests Through Neurazon (Canada)

3) Recommended Therapy

- **Plasticity Rehabilitation Therapy**
 - To be introduced **in 4 months** after establishing progress on the main protocol.
 - Supports improvements in processing speed, cognitive integration, and language pathways.


