### **Assessment Summary:**

Alwaleed was assessed on 02 July 2025 for concerns related to developmental and information processing delays. During the evaluation, he demonstrated characteristics aligned with **Hyperlexia Type 2**, trending toward **Hyperlexia Type 3**, although he does not meet the full clinical criteria for Hyperlexia 3 at this stage.

Findings indicate significant challenges in **information processing speed**, **auditory comprehension**, **and integration of verbal and non-verbal cues**. Despite these difficulties, Alwaleed shows advanced decoding and reading abilities typical of hyperlexia, paired with uneven cognitive development. The presence of global developmental delays necessitates a comprehensive approach to intervention and further assessment to clarify underlying neurological or metabolic contributors.

#### **Recommended Intervention Plan:**

#### 1. Development Protocol for Information Processing:

- Initiate an intensive developmental protocol tailored to support processing skills and integration.
- **Duration:** 4 months.
- **Review:** Reevaluate in-person to assess baseline progress and modify the plan accordingly.
- **Focus Areas:** Processing speed, auditory sequencing, integration, and receptive-expressive communication.

### 3. Recommended Therapy (Post Results):

### **Neuroplasticity Rehabilitation Therapy**

- Begin therapy focusing on cognitive and sensory integration.
- Frequency: 2–3 sessions per week.
- Start: As soon as possible (ASAP), even while awaiting test results.
- **Focus:** Strengthening functional connectivity, reducing overload, and targeting areas identified through testing.
