Overview

Ahmad attended a follow-up developmental progress assessment at EICADD Center Ajman. The current evaluation indicates **clear and meaningful improvement** since the previous assessment. Many of the **autism-related features that were previously observed have significantly resolved**, reflecting a positive response to the intervention protocols implemented to date.

Based on prior **precision health analysis**, the child's developmental profile was linked to **biological causes** that contributed to **information processing delays and developmental delays**, which in turn led to **acquired features of autism** rather than a primary or genetic form of autism. A substantial reduction in symptoms has been observed since the last assessment, indicating that the intervention approach has been effective. Continued support is recommended to consolidate gains and support ongoing development.

Recommended Plan

1) Development Protocol for Information Processing

- Continue the current development protocol for **4 months**, followed by a **re-evaluation**, preferably **in person**.
- Reassess progress to **establish an updated baseline** and refine the improvement trajectory.
- Maintain continuity of the existing intervention plan to support sustained developmental gains.

Recommended Therapy

- **Plasticity rehabilitation therapy:**
Recommended at **2–3 sessions per week**, to continue supporting neurodevelopmental progress and consolidation of gains achieved.

Conclusion

Ahmad has demonstrated substantial progress, with many previously observed autism features now resolved. The findings continue to support an interpretation of **acquired autism features secondary to biological and information processing factors**, rather than a fixed neurodevelopmental condition. With continued intervention, reassessment, and targeted therapy, the child remains **highly open to further improvement**.
