

## **Director's Report on Developmental Progress Assessment**

### **Overview:**

Elyas-Nadhém was assessed at our center on 07-09-2025. The evaluation revealed information processing delays and developmental delays leading to acquired features of autism. In addition, he shows signs of hyperlexia between types 2 and 3, though not fully developed at this stage. While he does not score as a case of autism, the findings indicate a need for ongoing structured intervention and further analyses to better understand the underlying contributors.

### **Recommended Plan:**

#### **1. Development Protocol for Information Processing**

- Implement a structured protocol for 4 months.
- Conduct a reevaluation after 4 months, preferably in person.
- Establish a baseline during reevaluation for measurable tracking.
- Continue with the intervention plan, making adjustments as needed.

#### **2. Main Recommended Analyses (through Neurazon – Canada):**

The recommended analyses are provided through Neurazon (Canada). These are optional recommendations, not obligatory, and are not performed directly at our centers. They are supportive measures to provide deeper insights into the child's developmental profile. Please refer to their report and assessment.

#### **3. Therapy:**

- Neuroplasticity rehabilitation therapy: Recommended to begin intensively in later stages, with structured sessions tailored to support information processing, language, and adaptive learning.

**Conclusion:**

Elyas-Nadhem demonstrates developmental and information processing delays, with acquired features of autism and elements of hyperlexia (between types 2 and 3). He does not meet autism criteria but requires targeted intervention and supportive therapies. Early and consistent intervention, paired with the recommended analyses, will help guide his developmental progress effectively.
