### **Director's Report on Developmental Progress Assessment**

### **Overview**

Saeed Hmoud Alameri visited our center for a developmental progress assessment. The evaluation indicates the presence of **information processing delays and developmental delays**, which have led to **features of Hyperlexia closer to Hyperlexia Type 2**, representing **acquired features of high-functioning autism** rather than a classical autism picture.

These findings suggest a neurodevelopmental pattern that is responsive to structured intervention. The child is capable of improvement, and continued targeted therapy is recommended. Further analysis will help refine the understanding of contributing developmental factors.

### **Recommended Plan**

#### **1) Development Protocol for Information Processing**

- Continue development protocol for **4 months**
- Reevaluate after 4 months, preferably in person
- Establish a developmental baseline at follow-up
- Continue structured intervention plan and home routine

#### **2) Main Recommended Analyses (Through Neurazon – Canada)**

*These analyses provide deeper insight into contributing biological and developmental factors.*

The recommended tests are conducted through **Neurazon (Canada)**, a bioinformatics company partnered with certified international laboratories. These are **optional recommendations**, not mandatory, and are provided to support deeper understanding of the child's developmental profile.

### 3) Recommended Therapy

- **Plasticity Rehabilitation Therapy** (in later stages when child is ready)
- Continue rehabilitation program, including:
  - Speech Therapy
  - Occupational Therapy
