Director's Report on Developmental Progress Assessment

Overview:

Miral Alfaez visited our center for a developmental progress assessment. The evaluation revealed that the child presents with **information processing delays** and **developmental delays**, which have contributed to **cognitive delays**, **speech delays**, and **features of autism**.

These findings suggest that Miral experiences challenges in communication, learning, and adaptive responses that are consistent with early signs of developmental and information-processing difficulties. The current assessment highlights the need for **further analyses** to determine the underlying biological and neurodevelopmental causes, guiding a more targeted intervention approach.

Early and continuous intervention at this stage is highly beneficial given the child's developmental age and neuroplastic potential.

Recommended Plan:

1) Development Protocol for Information Processing

- Continue with the **development protocol** for 4 months, followed by a **reevaluation**, preferably conducted in person.
- Reassess progress and establish a **new developmental baseline** after each stage.
- Continue with the **intervention plan**, emphasizing structured, play-based developmental activities to support communication and learning.

2) Main Recommended Analyses:

The recommended tests are conducted through **Neurazon (Canada)**, a bioinformatics company partnered with accredited international laboratories. These tests are **external**, **optional**, and **not**

performed directly through our centers. Parents are encouraged to follow the plan provided by Neurazon for details regarding sample collection, processing, and analysis timelines.

3) Therapy:

- **Neuroplasticity Rehabilitation Therapy:** To be introduced in **later stages**, as the child is not yet ready for this phase.
- Current focus should remain on **early developmental and speech-language therapy**, as well as **sensory and play-based interventions** to enhance communication, focus, and adaptive behavior.

The recommended tests are conducted through **Neurazon (Canada)**, a bioinformatics company partnered with accredited international laboratories. These tests are **external, optional, and not performed directly through our centers.** Parents are encouraged to follow the plan provided by Neurazon for details regarding sample collection, processing, and analysis timelines.
