

## **Director's Report on Developmental Progress Assessment**

### **Overview:**

Abdulmalik Mohammed Alzahrani was assessed at our center on December 6th, 2022. The evaluation revealed **information processing delays** and **speech developmental delays**. Despite these challenges, the child does not meet the criteria for an autism diagnosis at this time. Further testing and analysis are recommended to better understand the underlying causes and develop a comprehensive intervention plan.

### **Recommended Plan:**

#### **1) Development Protocol for Information Processing**

- Begin a **4-month** focused, non-chemical developmental protocol targeting information processing and cognitive skills.
- Conduct an **in-person reassessment** after 4 months to establish a clinical baseline and measure progress.
- Continue with the current therapeutic plan, adjusting as needed based on observed improvements.

#### **2) Main Recommended Analysis (Conducted Through Neurazon – Canada):**

### 3) Recommended Therapy After Determining the Causes:

- **Neuroplasticity Rehabilitation Therapy:**
  - To begin **immediately**, either intensively (1.5 to 2 months) or at a moderate pace, to enhance information processing and cognitive function.
- **Speech and Occupational Therapy:**
  - To support language development, communication skills, and sensory-motor integration.
