

Director's Report on Developmental Progress Assessment

Date of Visit: February 11, 2025

Child's Name: Jihan Salih

Date of Birth: July 2, 2020

Overview:

Jihan Salih was assessed today at the EICADD Center. The assessment revealed **information processing delays** and **intellectual developmental delays**, consistent with previous MRI findings conducted by neurologists in Sweden and Turkey. It is important to highlight that Jihan does not meet the diagnostic criteria for autism. Instead, the developmental delays appear to be associated with **genetic variants** found during prior analyses. Further assessment is required to better understand the underlying causes and support Jihan's continued developmental progress.

Recommendations:

1. **Development Non-Medicinal Protocol for Information Processing**
 - Implement the protocol for **4 months**, followed by a reevaluation of progress, preferably in person.
 - Reevaluate the developmental baseline and adjust the intervention plan accordingly.
 - Continue with the intervention plan after reevaluation.
2. **Main Recommended Analysis:**
 - **Precision Health Analysis – Neurazon (Canada)**
 - A comprehensive analysis to identify potential underlying causes.
 - **Sample Required:** Saliva
 - **Processing Time:** 4 months (business days)
 - **Frequency:** Repeated after 12 months
 - **Neuronal Growth Factors Absorption Analysis Screening – Neurazon (Canada)**
 - A detailed assessment of neuronal growth factors absorption.
 - **Sample Required:** Hair
 - **Processing Time:** 2 months (business days)
 - **Frequency:** Repeated every 6–12 months
3. **Recommended Therapy:**
 - **Technological Sessions Online** to support cognitive and information processing development.
 - **Brain Therapy (when possible for the family to be in the UAE).**

Follow-Up Plan:


It is crucial to reassess Jihan after the initial 4-month period to monitor her progress and update the intervention plan based on the findings from the recommended analyses.

Conclusion:

This report serves as a **rehabilitation assessment** and not a final medical diagnosis. Jihan has great potential for improvement with the right intervention and support. The assessment is open to change based on her progress. Continued evaluations and targeted therapies are essential in promoting her developmental growth.


