Assessment Summary:

Zain Thaer Nathif was assessed at our center due to concerns about his developmental and communication milestones. The evaluation revealed **information processing delays, developmental delays, and early hyperlexia**, currently classified as **Hyperlexia Type 1 with features progressing toward Type 2**, though not yet fully there. These patterns are leading to **acquired features resembling autism**, though the child does not currently meet criteria for Autism Spectrum Disorder (ASD).

The presence of early hyperlexia, coupled with processing and developmental delays, suggests the need for a customized plan and deeper biomedical analysis to support the child's cognitive and language development.

Recommended Plan:

1) Development Protocol for Information Processing:

- Initiate an **individualized** neurodevelopmental protocol to address information processing issues.
- Duration: **4 months**, followed by **in-person reassessment**.
- Establish a clinical baseline and continue with structured intervention based on progress.

2) Recommended Tests through Neurazon (Canada):

This is a developmental assessment, not a diagnosis. The child is open to improvement. Tests recommended are external through Neurazon (Canada) and not conducted directly at our center.

3) Recommended Therapy After Determining the Causes:

- **Mitotherapy (Light Therapy):**
 - Frequency: 1–2 sessions per week

- Intensive sessions are advised if the family cannot remain long-term in Jordan or the UAE
- **Speech Therapy (ST):**
 - Frequency: 2 sessions per week
- **Occupational Therapy (OT):**
 - Frequency: 2 sessions per week

1. Recommended Therapy:

- **Mitotherapy:** 1–2 light therapy sessions per week, or intensive protocol if unable to remain long-term in Jordan/UAE
- **Speech Therapy (ST):** 2 sessions per week
- **Occupational Therapy (OT):** 2 sessions per week


