#### Overview

Adam Loubnan Choughari visited EICADD Center Ajman for a developmental progress evaluation. The child has **shown improvement following the first step**, indicating a positive response to the initial intervention.

Adam presents with information processing delays and cognitive developmental delays, which have led to acquired autism features. These findings are linked to biological causes identified in prior external analyses conducted through Neurazon (Canada). Despite the presence of autism-like features, the assessment indicates that these symptoms stem from developmental delays rather than true classical autism.

Many of the previous symptoms have improved significantly, reflecting a **high potential for continued progress**, especially with structured intervention and developmental support. Further assessment remains necessary to ensure proper monitoring and to guide ongoing intervention.

#### Recommended Plan

### 1) Development Protocol for Information Processing

- Continue the protocol for 4 months
- Reevaluate the child after this period, preferably in person
- Establish a new developmental baseline
- Continue implementing the current intervention plan consistently

### 2) Main Recommended Analyses

- No further tests are required at this stage
- The **absorption analysis may need to be repeated** in future evaluations based on developmental trajectory and clinical need

### 3) Recommended Therapy

- Plasticity Rehabilitation Therapy
  - Continue with ongoing sessions
  - Therapy remains essential for strengthening developmental pathways and supporting information processing

### Notes on External Testing

All genetic and bioinformatics analyses referenced in this assessment were conducted through **Neurazon** (Canada), a bioinformatics company partnered with certified international laboratories. These analyses are external and are not performed directly at our centers.

Any future recommended tests are **suggestions**, **not obligations**, and are intended to provide deeper insight into the child's developmental profile. Families should refer to Neurazon's official plan for full information regarding external testing procedures.
