

Director's Report on Developmental Progress Assessment

Overview:

Ahmad was assessed at our center on 08-09-2025. The evaluation indicated information processing delays and global developmental delays. Reports from his neurologists in different countries suggest potential neuromuscular dystrophy, white matter delays, and epilepsy, which may be contributing to his developmental profile. At this stage, further analyses are required to clarify the underlying causes and to establish a precise treatment plan.

Ahmad demonstrates capacity for progress with structured intervention and remains open to improvement with the right therapeutic and medical support.

Recommended Plan:

1. Development Protocol for Information Processing

- Implement a structured 4-month protocol targeting information processing.
- Reevaluate Ahmad's progress after 4 months, preferably in person.
- Establish a new baseline during reevaluation for measurable tracking.
- Continue with the intervention plan, adapting as necessary.

2. Main Recommended Analysis (through Neurazon – Canada):

3. Therapy:

- **Neuroplasticity Rehabilitation Therapy**
 - Intensive therapy is recommended to begin as soon as possible.
 - Sessions should focus on strengthening cognitive processing, neuromotor coordination, and adaptive development.

Ahmad presents with developmental and information processing delays that are likely influenced by neurological and physiological factors. While neuromuscular dystrophy, white matter delays, and epilepsy are considerations based on external medical reports, structured intervention and further detailed analyses will help confirm the underlying causes and guide treatment. With appropriate therapy and medical follow-up, Ahmad shows potential for progress.


