### Director's Developmental Progress Assessment Report

#### Overview

Sari Yousef Aljahdal was assessed at our center on the above date due to concerns related to developmental regression and information processing delays. The evaluation indicated the presence of information processing delays along with regressive developmental delays that have led to acquired features of autism.

It is noteworthy that Sari has a twin sibling, which allows environmental causes to be reasonably excluded as the primary contributing factor. This finding suggests that the underlying cause is more likely biological in nature. Based on the clinical observations and current developmental presentation, further detailed biomedical analysis is required to determine the exact contributing mechanisms.

This assessment reflects the child's current developmental status and does not represent a final diagnosis.

#### Recommended Plan

##### 1. Development Protocol for Information Processing

- A structured developmental protocol is recommended for a duration of **4 months**.
- The child should then be **re-evaluated**, preferably in person.
- A clear developmental **baseline** will be established during the re-evaluation.
- The current **intervention plan should be continued consistently** during this period.

## 2. Recommended Therapy After Determining the Causes

- **plasticity rehabilitation therapy** is recommended at later stages after the underlying causes are identified.
- At the current stage, the child is **not yet ready** to begin this therapy.

### Notes on External Testing

The recommended tests are conducted through **Neurazon (Canada)**, a bioinformatics company partnered with certified laboratories worldwide. Please refer to the plan provided by Neurazon for further information. These are **recommendations and not obligatory**, and they are **not conducted directly through our center**.

### Conclusion

Sari's developmental profile indicates acquired autism features resulting from information processing and regressive developmental delays. Further biomedical investigation is necessary before determining advanced therapy stages. The child remains open for improvement with proper monitoring and targeted intervention.


