Recommended Plan:

- 1) Development Protocol for the information processing
 - For 4 months then we reevaluate the child, preferably in person
 - Reevaluate the plan and establish a baseline
 - Continue with the intervention plan
- 2) Recommended tests through Neurazon Canada:
 - Based on next evaluation we will determine if needed
 - Suggested for next time:
