### **Director's Report on Developmental Progress Assessment**

### Overview

Ghaya-Ahmed Alkaabi attended a developmental progress assessment at EICADD Center Ajman. The assessment indicates information processing delays and developmental delays, with associated Hyperlexia Type 1 features and speech developmental delays. At this stage, the child does not meet scoring criteria as an autism case, however, she requires further intervention to support development and reduce the risk of progression of acquired developmental features. Further analysis is recommended to better understand contributing factors and guide a more targeted plan.

### Recommended Plan

## 1) Development Protocol

- Implement a structured development protocol targeting information processing for 4 months, then reevaluate, preferably in person.
- During reevaluation, the plan will be reviewed and a **clear baseline** will be established to measure progress and guide the next stage.
- Continue with the intervention plan consistently during this period.

## 2) Recommended Therapy

After determining the contributing causes based on assessment findings and test results, the following is recommended:

- Plasticity rehabilitation therapy, intensive and/or Occupational Therapy (OT)
  - Suggested frequency: 2 sessions per week, planned to start after 4 months, aligned with the reevaluation timeline and overall progress.
