Overview

Carmen was assessed for developmental and information-processing abilities. The evaluation indicates that she has **information processing delays and developmental delays**, which are contributing to advanced reading-like patterns and **features of hyperlexia closer to Hyperlexia Type 2**. These features are associated with **acquired high-functioning autism-like traits**, although **she does not score as a case of autism**.

The child is capable of improvement and has strong potential for developmental gains with structured intervention and consistent support. Further analysis is recommended to identify contributing biological and developmental factors.

Recommended Plan

EICADD

1) Development Protocol for Information Processing

- Continue structured development protocol for **4 months**
 - Reassess afterward, preferably in person
 - Establish a **baseline and update plan** based on progress
 - Maintain consistent rehabilitation and structured activities

2) Recommended Analyses (External – Neurazon Canada)

The recommended tests are conducted through **Neurazon (Canada)**, a bioinformatics company partnered with certified laboratories worldwide. These tests are **optional and not obligatory**. They are **external and not conducted directly through our centers**. Parents wishing to proceed will follow the guidance and plan provided by Neurazon.

3) Recommended Therapy

- Plasticity rehabilitation therapy (*in later stages*)
- Occupational Therapy: **2 sessions per week**
- Speech Therapy: **2 sessions per week**
- Continue structured home-support and academic readiness activities


