

Director's Report on Developmental Progress Assessment

Overview

Jaber was assessed at our center for developmental progress. The evaluation revealed **information processing delays** and **global developmental delays**, which have contributed to **acquired features of autism**. Additionally, the child has a medical history of **Poland syndrome** and a **positive MRI for retrocerebellar arachnoid cyst**, which may further influence developmental outcomes. These findings highlight the need for structured intervention and further analyses to better understand underlying causes and support development.

Recommended Plan

1. Development Protocol for Information Processing

1. Continue with a structured developmental protocol targeting information processing.
2. Duration: 4 months, followed by reevaluation (preferably in person).
3. Reevaluate baseline progress at that time and adjust the plan accordingly.
4. Continue with the intervention plan to maintain consistency.

2. Main Recommended Analyses (Through Neurazon, Canada)

The recommended analyses are conducted through **Neurazon (Canada)**. These are external tests and not performed directly at our centers. Results will be reviewed and incorporated into the child's developmental plan once available. Please refer to their report and own assessment.

3. Therapy

- **Neuroplasticity Rehabilitation Therapy:** To be considered in later stages, as the child is not ready at present.

- **Speech Therapy (ST) and Occupational Therapy (OT):** Recommended to be initiated locally in Saudi Arabia to support communication, sensory integration, and adaptive functioning.

Conclusion

This assessment confirms that Jaber presents with global developmental and information processing delays leading to acquired autism features, compounded by underlying conditions including Poland syndrome and retrocerebellar arachnoid cyst. Despite these findings, the child remains **open for improvement** with structured protocols, targeted therapies, and advanced analyses.
