Overview

Samia attended a developmental assessment at EICADD Center Ajman. Based on the evaluation, the child presents with **information processing delays** and **developmental delays**, which are contributing to **Hyperlexia Type 2**, characterized as **acquired features of high-functioning autism**. At this stage, the findings indicate that **further analysis is required** to better understand the underlying contributing factors and to guide a more targeted and effective intervention plan. The child remains **open for improvement** with appropriate support.

Recommended Plan

1) Development Protocol for Information Processing

- Continue the **structured** development protocol for **4 months**, followed by a **re-evaluation**, preferably **in person**.
- Reassess progress to **establish a clear baseline** and define an **improvement projection**.
- Continue with the current intervention plan during this period.

Recommended Tests through Neurazon (Canada)

Recommended Therapy (After Determining the Causes)

- **Plasticity rehabilitation therapy (intensive):**
Recommended to start at **1–2 sessions per week**, with adjustment based on readiness, results, and observed response.

Conclusion

Samia's developmental profile reflects information processing delays with acquired features of Hyperlexia Type 2. Further targeted analyses are recommended to clarify biological, absorption-related, and gut-related contributors. With continued structured intervention and appropriately timed therapy, the child has potential for meaningful progress. Reassessment after the intervention period will allow refinement of the treatment approach.
